### DENTAL MATERIALS - THE ART AND THE SCIENCE

Dr. Sandrik is a graduate of Loyola University, Chicago, Illinois and Northwestern University, Chicago, Illinois. In 1977 he became an honorary member of Omicron Kappa Upsilon; in 1978 he received the Distinguished Service Award, from McHenry County; in 1985 he was elected Fellow of the Academy of Dental Materials. He is presently Professor and Chairman of the Department of Dental Materials at Loyola University School of Dentistry in Maywood, Illinois.

More dental materials have been developed over the past 20 years than in all the years since dentistry began, bringing to the profession some truly remarkable improvements - and quite a number we would rather not remember. Dr. Sandrik will sort through the confusion and hype and establish a groundwork for selecting the best, or at least those materials most likely to succeed in the future. Candid opinion of brand names will be presented along with practical discussion of sophisticated new materials, centering on a "how it works" format, or "why it doesn't work." Dr. Jackson received a BA in History at Duke University, his D.D.S. at the Medical College of Virginia School of Dentistry, and an Internship, Residency and Teaching Fellowship at the Harvard School of Dental Medicine. He was named Diplomate by the American Board of Pedodontics, received a Fellowship from the American College of Dentists, a Presidential Citation from the American Dental Association and a Fellowship from the Pierre Fauchard Academy. He is presently in private practice in Charleston, South Carolina.

Dr. Bain graduated from Glasgow University in Scotland in 1969 and conducted a general dental practice in Glasgow for 4 years. After one year in Churchill Falls, Labrador, he settled in Halifax, completed his D.D.S. and then pursued graduate studies at the University of Pennsylvania, where he obtained post-graduate certificates in Periodontics and Fixed Prosthodontics (Periodontal Prosthesis) as well as an M.S. in Education. From 1981 to 1987 he was Director of Occlusion and Head of the Division of Periodontics at Dalhousie University. He currently teaches part time and maintains a private practice limited to periodontics, prosthodontics, implantology and TMJ management. Dr. Bain has lectured extensively across Canada, in the United States, Europe and Africa.

While most dental education produces clinicians well able to complete individual dental procedures, it often falls short in areas of complex treatment planning and the interrelationship of the various dental disciplines. The purpose of this program is to present a rational, research based approach to the multi-disciplinary

management of the adult with complex dental needs, incorporating modern technology in managing an aging and more dentally aware population.

Topics to be presented include:

- Diagnostic Data Gathering for the multidisciplinary case
- Treatment options in the partially edentuous. The integration of fixed, removeable and implant prosthetics into comprehensive care. Planning for success.
- · Don't accept the unacceptable.
- Medico-legal considerations, prevention of problems and the use of a true, informed consent.
- Inflammatory control before, during and after orthodontics.
- Periodontal surgery in the orthodontic case, what, when and how? Grafting, impacted cuspids, frenectomy and cosmetic periodontics.
- · Occlusal objectives in the multidisciplinary case.
- Periodontal preparation for restorative dentistry.
   Needs for crown length, keratinized tissue, ridge preparation for pontic aesthetics and smile line symmetry.
- Removeable prosthodontics periodontal guidelines to ensure long-term success.
- The implant abutment; soft tissue preparation and correction to minimize problems.
- Sequence of therapy in anterior flaring and posterior bite collapse cases.
- · Uses and abuses of biteplanes.
- · Customized maintenance for advanced cases.
- Retreatment; turning a failure into a maintenance problem, building to the weakest link. Use of temporary cements, telescopes and flexible treatment planning to simplify retreatment needs.

The Woehler Research Group will hold its annual meeting in Halifax, Nova Scotia and autumn is an especially pleasant and colorful time to visit there. Halifax was the first English settlement in Canada, founded in 1749 by General Cornwallis. Respect for its heritage is reflected in the preservation and restoration of historic buildings erected by British and American immigrants of past centuries. Though Halifax is no longer ''small town," Haligonians haven't forgotten how people should be treated and are more than willing to help visitors.
